TRAVELING ALLOWANCE FOR ALL TYPES OF EXAMINATION WORK FOR EXAMINERS	i) ACTUAL EXPENDITURE (PREFERABLY BY THE SHORTEST ROUTE AND IN CASE OF OWN VEHICLE 10 RUPEES /KILOMETER) IS ALLOWED. ii) AIR TRAVEL IS PERMITTED TO EXAMINERS HAVING GRADE PAY Rs.6600/- OR HIGHER BY ECONOMY CLASS / AIRWAYS IF THE DISTANCE BETWEEN THE CITY EXCEEDS 500 KILOMETERS (PREFERABLY BY THE SHORTEST ROUTE ONLY, IN CASE OF NON AVAILABILITY OF FLIGHTS FROM THE SHORTEST ROUTE, THE EXAMINER SHALL HAVE TO GIVE AN UNDERTAKING REGARDING NON AVAILABILITY OF FLIGHT, ALSO IF THE DISTANCE IS LESS THAN 500 KILOMETER PERMISSION OF VICE CHANCELLOR SHALL BE MANDATORY) ADDITIONAL ACTUAL CHARGES SHALL BE ADMISSIBLE FOR TRANSPORT UPTO THE EXAM CENTRE/ HOTEL.	
B. LOCAL CONVEYANCE	i) ACTUAL CHARGES ON SUBMISSION OF BILLS. ii) CONVEYANCE ALLOWANCE IS ADMISSIBLE FOR LOCAL TEACHERS (WITHIN THE CITY) ONLY. iii) CONVEYANCE ALLOWANCE IS NOT ADMISSIBLE FOR THE TEACHERS WORKING IN THE SAME COLLEGE; IT IS ADMISSIBLE IF THEY WORK ON GENERAL HOLIDAYS.	
C. DAILY ALLOWANCE PAYABLE FOR EXAMINATION WORK	i) RS.500/-PER DAY/EXAMINERS ii) DAILY ALLOWANCE IS NOT ADMISSIBLE FOR THE TEACHERS WORKING IN THE SAME COLLEGE OR WITH IN THE AREA OF MUNICIPLE CORPORATION OF THERE HEAD QUARTER.
